## RIR Reciprocity Assessments(External)

During the Policy discussions in the AFRINIC-32 PPM on 17 Sep 2020, there was a debate regarding the reciprocity of one inter-RIR transfer policy proposal with ARIN. AFRINIC contacted the other RIRs to get their response regarding the reciprocity of four policy proposals (The resource transfer policy draft 3) was received in September 2020).

The information received has been compiled in this document.

This is not compatible with the RIPE Policies which state that when transferring Internet numberresources to another RIR, the RIPE NCC will follow the transfer policies that apply within its own service region. The RIPE NCC procedures state: "The transfer request is always initiated by the transferring party. The transferring party must send a request to the RIR where the Internet number resources are registered at the moment the request is made." The proposal only allows transfer of legacy resources and resources that been transferred into AFRINIC, and NOT resources from the AFRINIC pool. In principle, APNIC allows outgoing transfer of resources from the APNIC pool, but has a 5-year transfer restriction for 103/8 space.

ARIN	This proposal would be compatible with ARIN policy as written. 5.7.2.2 language does not always explicitly state that the source entity requirements apply solely to source entities, but this proposal is compatible with or without that clarification.
APNIC	Compatible for IPv4 Inter-RIR transfers. However there is ambiguity about APNIC to AFRINIC ASN transfers. We understand the text below allows transfer of ASNs out of AFRINIC region if they meet certain conditions. Does it imply transfer of incoming ASNs into AFRINIC is allowed?  "5.7.4 Transfer of ASN with IPv4 Resources  At the AFRINIC discretion, in the case where over 50% of the IPv4resources associated with an ASN are being transferred, that ASN may also be transferred at the same time."
RIPE NCC	compatible and reciprocal with the RIPE NCC's inter-RIR transfer policy.
LACNIC	First of all, LACNIC doesn't demand reciprocity in the inter-RIR policy. However, there are some aspects which are important to consider:  1. In section 5.7 IPv4 Resources transfers "This policy applies to an organization with a justified need for IPv4 resources (recipients) and organizations with IPv4 resources which no longer need (sources). "  Our procedure doesn't demand to ask the recipient the reasons for the transfer, we don't interfere in that part.  2. The policy says: "5.7.4 Transfer of ASN with IPv4 Resources". However, LACNIC policies only allow IPv4 transfers.
