TAKE NOTICE PRIOR TO CONTEMPT PROCEEDINGS FOR THAT:-

WHEREAS:

1. By virtue of an interim order dated 30 June 2022, issued by Honourable Judge P D R Goordyal-Chittoo and duly served upon You, Eddy Mabano Kayihura (“EMK”) on same day in case bearing reference *SC/COM/WRT/000454/2022* (hereinafter referred to as “**Interim Order**”) You, EMK, have been restrained and prohibited from:

(a) Acting on Board Resolution bearing reference Resolution 202110.655 given that AFRINIC NETWORK INFORMATION CENTRE (AfrinIC) Ltd (“**AFRINIC**”) does not have a Board of Directors in existence as per the law; and

(b) Acting as an ex officio director of AFRINIC until such time as the Board of AFRINIC is reconstituted by election.

And this pending the determination of the application bearing reference *SC/COM/WRT/000454/2022*.

2. Pursuant to the bylaws of AFRINIC, You, EMK, were appointed by the then Board of AFRINIC as Chief Executive Officer (CEO) and director thereof.
3. Further to the Interim Order being issued against you in clear and unequivocal terms, as formulated in para.1(a) and (b) above, it undeniably follows that all of your powers as CEO have automatically been suspended as a direct result thereof.
4. You, EMK, are therefore, hereby informed that you cannot, pursuant to the Interim Order and the provisions of the bylaws governing AFRINIC, exercise any of the powers falling under


the purview of your previous title as CEO and/or director of AFRINIC, including but not limited to its day to day management.

5. It has been brought to the attention of CRYSTAL WEB, that notwithstanding the clear and unambiguous terms of the Interim Order, You, EMK, are continuing to hold yourself not only as the CEO of AFRINIC but holding yourself as AFRINIC for the upcoming Kenya IGF 2022, Kenya's Premier Internet Policy Forum, in blatant breach of the Interim Order.
6. You, EMK, by continuing to hold yourself as CEO and/or director and/or AFRINIC itself, are deliberately flouting the Interim order and acting in contempt thereof.

NOW TAKE FURTHER NOTICE You, EMK that you are given, through the present notice prior to contempt proceedings, the opportunity to mitigate the extremely serious consequences of your persistent and deliberate breaches of the aforesaid Interim Order.

WARNING YOU, EMK, that in case you should fail to comply with the requirements and the exigencies of the present Notice and to pay the costs thereof, CRYSTAL WEB shall take against you such legal steps as it may be advised inclusive of but not limited to contempt proceedings to declare that You, EMK, have deliberately and wilfully flouted the Interim Order dated 30th June, 2022 and committing You, EMK, to fine and custodial sentence.
